The Union County Probate Court permitted Debtors to redeem the Property on November 3, 1995. The Property was sold at a sheriff's sale on November 20, 1995 for \$53,601.10, and on November 30, 1995, Union County issued a trustee's deed to the property. Accordingly, the Property was no longer part of the bankruptcy estate. 24 We agree with the district court that this issue is without merit. The record does not support Payne's claim that the Property was exempt from the estate prior to its sale, and upon its sale, no longer became part of the bankruptcy estate. Payne's argument in this regard is simply a recasting of the previous claim that the Property was never properly included in the estate to begin with. Thus, because the Property was no longer property of the estate, it became part of the bankruptcy estate. 25 Payne's next contention is that, upon the sale of the Property, it became part of his exempt property, making him immune from any collection action by the Trustee. Section 522 provides that a bankruptcy debtor may exempt, from the bankruptcy estate, property that is exempt under applicable state or federal law. 11 U.S.C. § 522. Thus, the debtor must choose to exempt the property that he wishes to place beyond the reach of the Trustee and bankruptcy court in order to be immune from the Trustee's claims. Payne chose to exempt the Property under the Code by claiming it as exempt in his schedules. He was granted this exemption on November 30, 1995, when the court confirmed his plan of reorganization. As a result of his exemption, the Property was removed from the bankruptcy estate. Payne's complaint that the Property became part of his exempt property, however, is essentially a recasting of his previous contention that the Property was never properly included in the estate to begin with. Payne, by his own actions, has not placed the Property beyond the reach of the Trustee. The Property remained property of the bankruptcy estate, subject to the Trustee's pending action to sell it. This Court has held that "[w]e may affirm the district court's decision

I was kind of an ambassador for the campaign at the time and that’s one of the only times I’ve ever been privileged to be in the Oval Office.” Brazile also

said that Clinton's best chance for winning the election is if the FBI or Congress release a transcript of its interview with her in the interview.
